Background Information:

History: Thomas Bourrie worked as a carpenter and contractor in Joliet from the early 1900s through the late 1940s. Bourrie was born in Canada on February 12, 1882. It is unclear when he immigrated to the States. By 1909 Bourrie was living in Joliet at 210 Willow Ave. with his wife, Altha, and together they had a daughter, Loretta. Bourrie passed away in 1951 and is buried at Mount Olivet Cemetery.

Scope and Content Arrangement: The Thomas Bourrie Records are composed of primarily financial documents in relation to his work as a contractor. This includes tax records, bank statements, business receipts, invoices, property deeds, and financial ledgers. Of note are Bourrie's ledgers used to note project expenses. These ledgers include the projects he was working on, as well as the cost of materials, cost of labors, and in some instances, drawings of the project plans. All materials in this collection have been arranged chronologically. The collection contains a few oversized items which can be found in drawer 7 of the oversize map cabinet located in the Curator's Office.
