Background Information:

History:

Phoenix Horse Shoe Company, founded by Charles W. Miller, began operations in Hartford, CT in 1882 under the original name Spring Horse Shoe Company. By 1884, the Spring Horse Shoe Company purchased a manufacturing plant in Poughkeepsie, NY and renamed the company the Phoenix Horse Shoe Company. After ten years of operation, the plant in Poughkeepsie was found to be inadequate to keep pace with increasing demand, the company purchased land in Joliet in 1893, erecting a second factory location. Along with the purchase of a second factory in Joliet the company relocated their general offices to the Rookery Building in downtown Chicago and maintained executive offices on Madison Ave. in New York. Up until the end of the second world war Phoenix was one of only two horse shoe manufacturers in the nation, the second being the Bryden Neverslip Horseshoe Co. In 1928 the company was acquired by Phoenix Horse Shoe and their manufacturing facilities were converted to the production of commercial forgings and flanges renaming the plant the Phoenix Forging Company. Over the next several years Phoenix purchased several other horseshoe facilities, but unlike the Bryden Co. Phoenix often liquidated or moved operations.

In 1957 the Union Car Company purchased Phoenix along with all divisions and subsidiaries. In 1971 Union Car Company was purchased by the Trans Union Company, who then sold all of the original Phoenix facilities, except for the Phoenix Forging Company, to the Continental Steel Corporation.

Scope and Content Arrangement:

The Phoenix Horse Shoe Collection contains correspondence, business agreements, blueprints, financial records, catalogs, publications and photographs pertaining to the operation of the Phoenix Horse Shoe Co. The collection has been arranged into 4 series based on the content of documents and the materials in each series are arranged chronologically.

There are a small number of oversized materials in the collection. They have been listed in Series 4 of the collection and are recorded in the finding aid with their original series number as well. All oversized materials for this collection are housed in oversize storage drawer 7 located in the Curator's Office.
